Throughout the ongoing pandemic era of education, Stockton Collegiate has been in contact with students and families through surveys, ManageBac messages, teacher contacts, counselor outreach, and IT support. Feedback infused the development of how to allocate the ESSER III funds. The multiple forms of outreach will continue throughout the year in order to inform the most effective use of the funds.

Teachers and other instructional support team members met during professional development days at the end of the 2020-21 school year to plan for the 2021-22 school year based on year-end assessments (academic and socio-emotional) of the students and to collaborate about best approaches for the beginning of the 2021-22 school year. Educational Specialists are part of collaborative teaching teams and participated with the general education teachers in the planning for academic and socio-emotional support for students in the 2021-22 school year.

Stockton Collegiate's three-member administrative team (Head of School, 2 Administrators) work in concert on a daily basis. As part of the planning for all elements of the 2021-22 school year, the including specifically the use of ESSER III funds, the administrative team consulted with each other. Stockton Collegiate's administrative team is both the school level (principal) and district level (district administrators/superintendent) leadership team.

Families that speak a language other than English are supported by on-site translators. Printed information is translated into languages other than English to the extent possible. Stockton Collegiate uses an on-call translation service to provide verbal translation for a wide range of languages as needed.

At Stockton Collegiate traditionally underserved students include socio-economically disadvantaged students, EL students, students whose goal is to be first-generation college students, and students whose ethnic or racial background has traditionally limited their educational opportunities. Most of Stockton Collegiate's student population fits in one of those categories. Stockton Collegiate's mission is to provide a college preparatory, career ready, IB education to all students beginning in kindergarten. Tribes, Civil Rights Organizations, and Individuals/Advocates are invited to participate in surveys about the use of ESSER III funds.

Stockton Collegiate contacted these traditionally underserved groups through surveys, ManageBac messages, teacher contacts, counselor outreach, and IT support. Feedback from these contacts infused the development of how to allocate the ESSER III funds. The multiple forms of outreach will continue throughout the year in order to inform the most effective use of the funds.

Parents and student were clear about concerns for social and emotional well-being upon the return to in-person instruction.

Teachers and other instructional support team members expressed concern about strategies to best support students who are returning to school with the potential of being significantly below grade level and emotionally uncertain about how to return to the classroom.

These concerns influenced the decision to increase the counseling staff and the number of instructional aides. These concerns also influenced the decision to expand some support components of the ELA curriculum to all grade levels.

- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
